The **VOTE for KIDS** campaign is an initiative by the independent, nonpartisan organization Westchester Children's Association. It aims to elevate Westchester's children and youth to the top of the public agenda among candidates, elected officials, media, and the general public during the upcoming elections.

As a critical part of the campaign, candidates running for election in the New York State Senate and the New York State Assembly were invited to answer questions about issues affecting Westchester's children and youth. Only those candidates running in the general election and in districts that encompass municipalities in Westchester County were surveyed.

This is a non-partisan effort; Westchester Children's Association does not support or oppose any candidate for public office. We understand that voters do and should make decisions based on a variety of qualifications that go beyond responses to any one questionnaire.

Candidate responses or lack thereof are included in their entirety and in the exact manner that we received them. We are grateful to the candidates who took the time to complete the survey.
